

Notice of Race Burton Sailing Club Regional Windsurfing League & Raceboard Open Meeting Saturday 6th May 2023

1. Rules

1.1. The regatta will be governed by The Racing Rules of Sailing (except as modified in the Sailing Instructions), the Rules of Techno Class Association, the Sailing Instructions and this NOR. In the event of conflict the Sailing Instructions shall prevail.

1.2. Competitors should note that Burton Sailing Club implements the RYA Racing Charter and that they will be required to undertake to sail in compliance with the Charter, which can be found at the front of the RRS.

1.3. Rights to use Names & Likeness: Competitors automatically grant to the organising authority without payment the right in perpetuity to make, use and show any motion pictures, still pictures and live, taped or filmed television of or relating to the event.

1.4. Advertising will be in accordance with ISAF regulation advertising code 20, with the exclusion of clause 20.8.

2. Eligibility and Entry

- **2.1.** The regatta is open to all windsurfers.
- **2.2.** The 3.5/4.5/5.8 Youth fleets and Techno 6.8/7.8 fleets are open to competitors aged 18 or under as at 31st December 2023.
- **2.3.** The 7.8 and 9.5 Raceboard fleets are open to competitors of all ages.
- **2.4.** All competitors shall complete the registration form, which should be submitted to the Race Committee prior to the start of racing. Registration on the day will be in the clubhouse from 9am but pre-registration is requested at <u>Midlands Windsurfing League Burton SC 6/5/2023 (google.com)</u>
- **2.5.** Entry fee for the event is £10 per youth entry, and £15 per adult entry.

3. Event Schedule

- **3.1.** There will be a maximum of 9 races.
- **3.2.** There will be a briefing in the Dinghy Park at 10:30 on Saturday 6th May 2023
- 3.3. First Warning Signal Not Before 10:55 on Saturday 6th May 2023
- 3.4. No Warning signal Later than 15:55 Saturday 6th May 2023



4. Sailing Instructions

4.1. The sailing instructions will be available at registration, and at www.<u>http://www.burtonsailingclub.co.uk</u>

5. Scoring System

- 5.1. The rules of racing RRS Appendix A will apply.
- 5.2. The maximum number of races shall be 9
- **5.3.** There will be 1 discard if 3 races are sailed, 2 discards if 7 races are sailed, 3 discards if 9 races are sailed.
- 5.4. Minimum number of races to constitute a series will be 1.

6. Local Rules

6.1. All competitors agree to be bound by the Rules and Bye-Laws of Burton Sailing Club.

7. Facilities

7.1. Competitors and their families shall be deemed to be members of Burton Sailing Club for the duration of the event.

7.2. Camping and campervans are allowed on site by prior arrangement only.

7.3. Dogs are allowed on site but must be kept on a lead and under control and are not allowed in the clubhouse

7.4. Catering will be available all day, pre order all catering at registration

8. Disclaimer of Liability

8.1. Competitors are entirely responsible for their own and their boats safety, whether afloat or ashore and nothing, whether in the Notice of Race or Sailing Instructions or anywhere else reduces this responsibility.

8.2. Nothing done by the organisers can reduce the responsibility of the owners and, or competitors, nor will it make the organisers responsible for any loss, damage, death or personal injury, however it may have occurred, as a result of the boat taking part in the racing. The organisers encompass everyone helping to run the race and the Association as the co-organising authority, the race committee, the race officer, patrol boats, beach masters, and shore crews.

8.3. The provision of safety boats does not relieve the boat of her responsibilities. By launching, a boat and its crew are presumed to be fit and competent for the prevailing conditions.

9. Insurance

9.1. Each participating boat shall be insured with valid third-party insurance with a minimum cover of at least £3,000,000 per event (or the equivalent in any other currency).
